2. Any and or all invoices by any and/or all attorneys and law firms who provided services to the Township regarding Dr. Mollick's 10/18/10 request to review the Susan Caughlan property file of 2686 Overhill Dr. and Township response to that request.
3. Any and or all invoices by any and/or all attorneys and law firms who provided services to the Township regarding the appeal of the Township's denial of Dr. Mollick's 10/18/10 request to inspect Supervisor Susan Caughlan's property file (OOR DKT 2010-1186) to date.
