I would like these emails regardless as to whether they were transmitted on the personal computers and personal email accounts of the Supervisors and/or the employees.

I would like to review any notes, memos, faxes, and/or written documentation of any kind that are in the possession, custody and/or control of the Worcester Board of Supervisors either collectively and/or individually concerning Township business and/or activity involving Susan Caughlin and/or David Brooks and/or the 2686 Overhill Road driveway paving of the Right-of-Way situation, including but not limited to, the violation notice sent dated March 18, 2009 since my information request dated October 25, 2009 to present.

I would like to review any and/or all emails that are in the possession, custody and/or control of the Worcester Board of Supervisors including Supervisors Art Bustard and/or Steve Quigley and/or John Harris and/or Susan Caughlin either collectively and/or individually regarding OOR Appeal of James Mollick v. Worcester Township, Final Determination Docket No. AP 2009-1064 for the past 1 year regardless as to whether they were transmitted on the Supervisors personal computers and/or personal email accounts.

I would like to review the dates of transmission only of any and/or all emails between Supervisor Susan Caughlin and Solicitor Garrity regarding the OOR Appeal Docket No. AP 2009-1064 (James Mollick v. Worcester Township) regardless as to whether they were transmitted on the Supervisors personal computers and/or personal email accounts for the past 1 year.

I would like to review any and/or all emails to and/or from Supervisors Art Bustard and/or Steve Quigley and/or John Harris and/or Susan Caughlin and/or Township Manager John Cornell and/or Assistant Manager Eunice Kriebel and/or current Township Manager Fox regarding the Township's new resolution on public participation at Board meetings including but not limited to the 5 minute rule regardless as to whether they were transmitted on the Supervisors and/or employee's personal computers and/or personal email accounts for the past 2 years.
9. I would like copies of any and/or all bills, statements, invoices, charges from any and/or all attorneys who provided services regarding and/or pertaining to the Township's new resolution on public participation at Board meetings including but not limited to the 5 minute rule.
10. I would like a copy of the current Township Manager's employment agreement and/or contract.

If you intend to deny this request, please state the grounds upon which you intend to do so.

If the records are available in electronic format, this medium is preferable. I would like to review the records as stated first and then copy those records that I feel necessary.
