

INDIVIDUAL USE RENTAL APPLICATION Fall 2024

SOME INFORMATION...

- The Fall Season begins August 1 and ends November 30.
- The registration period for Group 1 Renters begins on the second Monday in May.
 Group 1 Renters include Township-based organizations that primarily serve Township residents only, and that are renting facilities for events that are primarily for Township residents only.
- The registration period for Group 2 Renters begins on the third Monday in May. Group 2
 Renters include organizations not included in Group 1 and that primarily serve youth ages 17
 and under.
- The registration period for Group 3 Renters begins on the fourth Monday in May. Group 3 Renters include any organization not a Group 2 or Group 3 organization.
- Rentals are available on a first-come, first-served basis. Applications are processed in the order of the date a complete application is received. No application date may be earlier than the date on which registration opens for the applicable organization group, as noted above.

REQUIRED APPLICATION MATERIALS...

- A completed application includes all of the following items. Applications that lack any of these
 items will be deemed incomplete, and will not processed.
 - 1. a completed Rental Application Form;
 - 2. a certificate of insurance that names Worcester Township as an additional insured if the rental is made on behalf of an organization or any other entity;
 - 3. one check for the rental fee due, in full, payable to Worcester Township;
 - 4. one check for the security deposit due, in full, payable to Worcester Township; and,
 - 5. current or previous year participant information that includes participant age and residency (for renters seeking a residency and/or age discount).

RULES AND REGULATIONS

- 1. All Renters wishing to rent and/or utilize a facility must acquire a permit from Worcester Township. The permit must be available during use and presented to any Township representative upon request. The Renter shall ensure all coaches and group leaders receive and understand that permits must be on site during facility use.
- 2. Permits are not transferable. The Renter will ensure that no unauthorized third party is granted permission to use the facility or any portion thereof without prior Worcester Township approval. Subleasing of fields will result in revocation of all permits.
- 3. Any person found guilty of damaging, destroying or defacing Worcester Township property may be excluded from further use and shall be held responsible for such damage. Renters are responsible for reimbursement for the cost of damages occurring during use. Renters may forfeit their assigned fields in order to compensate other groups that may have been affected as a result of such damage.
- 4. The Renter is responsible for the conduct of all participants, spectators, and others connected with the activity, including visiting teams. Worcester Township reserves the right to suspend or expel any Renter, group of individuals or individual from use of the public athletic facilities if their use of the fields causes or may cause damage to the facility or harms or threatens to harm any individual.
- 5. The Renter is responsible for cleaning facilities rented immediately following use. This includes collecting trash and placing trash in trash receptacles. The Renter assumes all liability for the cost of excessive clean-up, loss, breakage or removal of Township property resulting from the permitted activity. Failure to comply will result in the Renter being billed, and being required to pay for, said additional cost. All facilities shall be cleaned immediately following the permitted use.
- 6. The Renter may not construct, modify, or make other physical changes to any facility unless prior written permission is received from Worcester Township.
- 7. Marking game lines, raking and dragging, aligning field boundaries, and other aspects of field preparation for a game or event are the responsibility of the Renter.
- 8. The Renter must use good judgment when assessing field conditions and the Renter shall not use fields when conditions are such that use is likely to cause injury to participants or result in damage to the playing surface. Worcester Township reserves the right to close any facility or portion thereof when field or weather conditions deem it necessary.
- The Renter agrees to conduct warm-ups or practice for a game in an area and manner that is not dangerous to spectators or individuals using other fields or injurious to other fields on the assigned grounds.
- 10. The Renter will ensure that alcoholic beverages are not brought on to the grounds of any Township facility.
- 11. The Renter agrees to park automobiles and other vehicles in designated parking lots only. Automobiles and other vehicles are not allowed outside designated parking lots unless prior approval is granted by Worcester Township. The Renter is responsible to inform all participants and spectators as to permitted parking areas, and the Renter may be held responsible for damages to Township property caused by automobiles and other vehicles accessing areas outside designated parking lots.
- 12. The Renter agrees to obtain permission from the property owner before retrieving balls or other equipment from adjacent private property.
- 13. Playing on wet fields is prohibited.
- 14. Field use begins and ends at the times stated on the permit, and this includes set-up and clean-up. The Renter is not allowed on fields prior to the start time on the permit and are required to have the fields clean, picked up and be off the fields at the ending time indicated on the permit.
- 15. Portable goals and/or markers are allowed, but must be removed daily.
- 16. Amplified sound is not allowed on any field. Use of artificial noisemakers, horns, rattles, bells or whistles by spectators are not allowed.
- 17. Barbeque use and open fires are not permitted.

- 18. The Renter shall not charge admission, sell tickets, take collections, sell items or services or otherwise engage in fundraising in Worcester Township facilities.
- 19. Pets must be on a leash and their litter collected and disposed of appropriately.
- 20. Speed limits on Township property must be observed at all times.
- 21. The Renter is required to comply with all applicable laws set forth by Township Code, and State and Federal Law.
- 22. Worcester Township reserves the right in its sole discretion, to prohibit the Renter from using the facility for any reason, in which instance the Renter shall receive a refund of any rental fee paid, prorated to the amount of time the facility was unavailable, and no other consideration shall be due to Renter from the Township.
- 23. The Renter shall provide a valid certificate of insurance to the Township, if acting on behalf of an organization, which names the Township as an additional insured. This permit shall be immediately voided in the event the certificate of insurance lapses and/or the Township is removed as an additional insured.
