MINUTES WORCESTER TOWNSHIP BOARD OF SUPERVISORS WORKSHOP MEETING WORCESTER TOWNSHIP COMMUNITY HALL June 19, 2024 – 6:30 PM

CALL TO ORDER

The meeting was called to order at 6:32 PM.

PLEDGE OF ALLEGIANCE

ATTENDANCE

All members of the Board of Supervisors were present.

ANNOUNCEMENTS:

The Interim Township Manager stated that the meeting was being recorded for future broadcast.

INFORMATIONAL ITEMS

PUBLIC COMMENT

WORKSESSION TOPICS

1. Fire Department Training Building Discussion

Brandon Raquet, Assistant Chief of the Worcester Volunteer Fire Department (WVFD), oversees training of the WVFD. He then described some of the training they hold in and out of house.

Mr. Raquet stated that the WVFD makes sure that the drill nights are useful and people want to be there. He highlighted the 41-person-average-attendance on drill nights, which is some of the highest in the County.

Mr. Raquet indicated that burn drills are held at facilities outside the township. The County facility, which they often use, is approximately 40 minutes away from the township which takes the volunteers away from the township at times when they might be needed.

WVFD also requires active interior burn training once a year to be qualified to go into a building.

Mr. Raquet finished up with asking the township to help with the permits and location identification. He specifically identified Nike Park as a potential location for the burn site.

The WVFD would like to use the shipping container version, securing it with a fence and adding lighting for better training at night.

Mr. DeLello commented that a training facility makes sense but is concerned about size and the intended use of Nike Park. This might include restrictions on the open space land. He was also concerned about safety surrounding the site.

Mr. Raquet responded that much of the air quality risk would be mitigated by not burning furniture or other carcinogens.

Mr. DeLello also voiced concern that the timing was too quick to make an informed decision.

Mr. Raquet then informed the Supervisors that support from the township would be minimal.

Mr. Quigley clarified the size of the concrete pad and asked about the scheduling of other facilities.

Mr. Raquet indicated that scheduling has not been much of an issue.

Mr. Quigley then asked about the ability to run classes.

Mr. Raquet indicated that they would be able to run Firefighter 1 courses.

Mr. Betz clarified that stakeholder management would need to be utilized. He also suggested that other groups could train at the facility as well.

Mr. DeLello suggested that the township investigate if there are any obvious obstacles like deed restrictions.

MINUTES WORCESTER TOWNSHIP BOARD OF SUPERVISORS BUSINESS MEETING WORCESTER TOWNSHIP COMMUNITY HALL June 19, 2024 - 7:00 PM

CALL TO ORDER

The meeting was called to order at 7:04 PM.

PLEDGE OF ALLEGIANCE

ATTENDANCE

All members of the Board of Supervisors were present.

ANNOUNCEMENTS:

The Interim Township Manager stated that the meeting was being recorded for future broadcast and informed the public of an executive session that occurred on May 23, 2024, to discuss personnel matters.

INFORMATIONAL ITEMS

Route 73 Construction & Traffic Pattern – Mike Snizik, Enbridge

Mike Snizik indicated that Enbridge is an interstate natural gas company which performs anomaly maintenance. There are two lines they are responsible for that run under Skippack Pike. Enbridge runs tooling through the lines to ensure safety. The sensors mark any issues, and the company excavates and repairs any damage. There are two 26-inch pipes and they are vital infrastructure. The work is anticipated to start around September 14th. There won't be any loss of service as there will simply be no gas charged in the pipe as the crews are working. PennDOT has granted a permit and Mr. Snizik is concerned about the traffic management from a speeding perspective. He also gave preliminary traffic strategies. The work will take a minimum of 20 days.

Mr. DeLello asked about safety concerns. Mr. Snizik responded that there are no more safety concerns than any normal construction site with diesel and hydraulic fluid.

Mr. Snizik stated that tooling ran through the lines identified a potential issue, however there is no guarantee the pipe needs maintenance.

Mr. Quigley asked if there was anywhere else that needed to be fixed. Mr. Snizik responded that these were the only two areas that needed additional investigation. Mr. Quigley asked what happens if the township says no. Mr. Snizik indicated that no one says no, he then elaborated that the department of energy has standards that they must meet.

PUBLIC COMMENT

Doris Dixon of Bustard Road made a reference to the work session concerning the potential fire training facility and suggested that the fire department do a dry run in that area prior to deciding to use the Nike Park property. Ms. Dixon further discussed a dispute with her neighbor. She asked about whether her neighbor running a doggie daycare business at his residence was permitted. She went on to complain about a fence her neighbor erected.

Gary Volpe of Towamencin Township, the owner of 3238 W Germantown Pike, which is zoned AGR, spoke concerning his property. In 2002, by special exception, they were approved for a Roofing business. They have since moved out. In 2015, the Batter's Box was approved for Baseball skills by special exception and that lease has ended. Mr. Volpe has signed a new lease with Integrate for Good, an organization dealing with special education and workforce development. Mr. Volpe applied for a Use and Occupancy permit and was denied due to the proposed use not meeting use requirements within the AGR zoning district.

Mr. Volpe indicated that Integrate for Good will lose grant funding if they are not operational by July. Mr. Volpe requested the Board overturn the denial of the Use and Occupancy issued by the Zoning Officer.

Township Solicitor Wendy McKenna indicated that the proposed use required relief from the Zoning Hearing Board and that the Board of Supervisors does not have the authority to overturn the Zoning Officer's decision.

Dr. Bev Weinberg, Executive Director of Integrate for Good, explained that an extension would not work because the grant requirements are federally mandated. Dr. Weinberg stated that they are not a camp, school, or developmental center, and that they may need to take legal action.

Jay Finnigan, Interim Township Manager, indicated that the proposed use clearly fits the definition within the zoning ordinance based upon a review of Integrate for Good's website.

CONSENT AGENDA

A motion to approve the consent agenda was made by Supervisor Betz and seconded by Supervisor Quigley. The motion passed unanimously.

MOTION

a) Motion to authorize Township Solicitor to prepare a Resolution approving the 1543 Trooper Road Lot Line Change with the condition that no prior deed restrictions are being broken.

Michael Bayinski an engineer from Robert Blue Consulting presented the minor subdivision of 1543 Trooper Rd. The purpose is to change the lot line so that the existing driveway to the house is on the user's property and combine two lots to make one conforming lot.

One waiver was requested for the plan size, so the engineers could fit the property on one sheet rather than extending onto multiple sheets.

Supervisor Betz made a motion to authorize the Township Solicitor to draft a resolution to approve the lot line changes assuming no prior deed restrictions are being broken. The motion was seconded by Supervisor Quigley, and the motion passed unanimously.

b) <u>Motion to approve a waiver of land development for the waiver of land development</u> <u>application 2024-01, Pennsylvania American Water Company, 2523 Skippack Pike, for a</u> <u>material storage structure.</u>

Mr. Evarts informed the Board that a waiver of land development was granted for a water tank in 2018, and therefore, it was appropriate for the applicant to be in front of the Board for this project as well.

Anthony Carmassi and Michael Evenson were in attendance from PA American Water Company. Mr. Carmassi presented the site plan and what they intended to build.

Mr. Quigley asked about screening and Mr. Carmassi indicated that they plan on adding more evergreen to an already forested site.

Mr. Carmassi added that PA American planned on adding stormwater structures.

Supervisor Betz made a motion to approve the waiver of land development. The motion was seconded by Supervisor Quigley, and the motion passed unanimously.

c) <u>Motion to appoint Environmental Engineer and authorize Interim Township Manager to execute agreement.</u>

Supervisor DeLello provided background for the Board and those in attendance indicating that the Board was interested in hiring an Environmental Engineer to review the City View environmental situation.

Supervisor Betz indicated that AET is local and is qualified to do the job.

Supervisor DeLello thinks Pennoni is better because they can do more and they have a team of environmental people. He thinks that Pennoni suits the township's needs better.

Supervisor Quigley has been concerned about the property for a couple of months. He is deeply concerned about the potential soil contamination at the property but, he was not prepared to make a motion to hire an environmental engineer that evening.

Supervisor Betz made a motion to hire AET. There was no second.

Supervisor DeLello made a motion to hire Pennoni. There was no second.

Both motions failed.

 Motion to authorize Interim Township Manager to execute an Agreement for Traffic Engineering Services – Data Collection and Evaluation for Traffic Signal Retiming at Skippack Pike and Bustard Road – in the amount of no-to-exceed \$5,100.

Mr. Finnigan, the Interim Township Manager, gave background on the issue. At the traffic signal at Skippack Pike and Bustard Road, there have been multiple complaints from residents and from state elected officials. The timing has not been analyzed since 2004. Mr. Finnigan received a quote of \$5,100.

Supervisor DeLello clarified that this would be the first step in changing the timing of the lights.

Supervisor Betz asked how the township decides what intersections to modify.

Mr. Finnigan clarified that this is mostly in response to resident complaints.

Supervisor Betz asked if this intersection is particularly bad.

Township staff indicated that this intersection has had several bad collisions and a total of 16 in the past 12 months.

Supervisor Betz moved to authorize the Interim Township Manager to execute the agreement. The motion was seconded by Supervisor Quigley. The motion passed unanimously.

e) <u>Motion to authorize CKS and Township staff to prepare and advertise the Bid Documents for</u> <u>the test boring, excavation, grading, slab installation, electrical work, drainage, etc. for the</u> <u>installation of a band shell at Heebner Park.</u>

Supervisor DeLello stated that it was a bit early to advertise for this bid.

Supervisor Betz indicated that the Planning Commission should take a look at other sites or positions on Heebner Park.

The Board reached a consensus to have the Planning Commission look at the band shell project.

f) <u>Motion to authorize Intercounty Investigations & Solutions to provide an Executive Level Pre-Employment Background Investigation for the Worcester Township Manager Candidate upon the issuance of a Conditional Offer in the amount of \$3,495.</u>

Supervisor DeLello gave some background information concerning the background check for the future Manager.

Supervisor Betz asked if this was standard procedure which was confirmed by Supervisor DeLello.

Supervisor Betz made a motion to approve Intercounty Investigative Solutions to do a background check of an eventual final candidate for Township Manager at the cost of

\$3,500.00 and the Interim Township Manager is authorized to sign the proposal. Supervisor Quigley seconded the motion. The motion passed unanimously.

g) Motion to authorize submittal of Matching Funds Commitment Letter to fund approximately \$296,000 for Skippack Creek Alliance project located in Worcester Township in anticipation of submitting a Growing Greener grant application for up to \$500,000 in grant funding.

Mr. Evarts gave background on the Skippack Creek Alliance. The township would be responsible for approximately 16.25% of the \$296,000, or about \$50,000. Some municipalities would be responsible for more.

This project is a stream bed restoration on Zacharias Creek.

Supervisor Betz asked if the other municipalities had approved their commitment letter. Mr. Evarts did not know at that time.

Supervisor Betz made a motion to approve the submittal of a commitment letter. The motion was seconded by Supervisor Quigley.

Bob Andorn of Worcester made comment that he thought the agenda and the commitment letter was unclear.

The motion passed unanimously.

h) Motion to authorize Interim Township Manager to execute Land Rental Agreement between Worcester Township and Drew R. Bechtel for the property located at 2955 Fisher Road for the period of May 28, 2024, through December 31, 2024.

Mr. Finnigan provided background concerning the field cutting, hay bailing, and removal agreement. He stated that this allows township personnel to avoid mowing the fields.

Supervisor Betz clarified that the township is getting paid to allow someone else to do maintain the field.

Supervisor Betz moved to authorize the hay lease. It was seconded by Supervisor Quigley.

Mr. Andorn clarified that the township was getting paid.

The motion passed unanimously.

i) Motion to authorize advertisement for amendment to Zoning Ordinance related to fence height, accessory structure height, and size.

Supervisor DeLello gave some background information concerning the subject of the zoning ordinance amendment.

Township Solicitor Wendy McKenna presented the amendments. She also clarified the process of ordinance amendments and added that her office performed research to draft these amendments.

Supervisor Betz commented that the that he agrees with most of the ordinances, but thinks the accessory structures are probably the most complex.

Supervisor DeLello stated that the purpose behind amending the ordinance is to reduce the number of people that need to go to the Zoning Hearing Board for similar maters.

The Board redirected the ordinance amendment discussion to the Planning Commission.

 Motion to authorize Interim Township Manager to execute agreements with Triad Truck Equipment for purchase and installation of two Galion Model 130U Municipal Dump Body packages, lights, hydraulics, and Boss 10-foot Heavy Duty Straight Blade Plow.

Supervisor DeLello and Mr. Finnigan provided background on the matter. Mr. Finnigan stated that this was part of the 2024 budget and the total cost of the purchase is \$120,000.

Supervisor Betz moved to authorize Interim Township Manager to execute agreements with Triad Truck Equipment for purchase and installation of two Galion Model 130U Municipal Dump Body packages, lights, hydraulics, and Boss 10-foot Heavy Duty Straight Blade Plow. The motion was seconded by Supervisor Quigley and passed unanimously.

k) Motion to ratify the hires of Douglas Lapine and Jaden Newman as Public Works Laborers; <u>full-time employees.</u>

Supervisor Betz made a motion to ratify the hires of Douglas Lapine and Jaden Newman as Public Works Laborers; full-time employees. The motion was seconded by Supervisor Quigley and passed unanimously.

1) Motion to accept resignation of Fire Marshal Andrew Raquet.

Supervisor DeLello expressed his thanks to the fire marshal for his service.

Supervisor Betz made a motion to accept the resignation of the fire marshal. Seconded by Supervisor Quigley. The motion passed unanimously.

m) Motion to accept a Deed of Dedication, Temporary Construction Easement, Stormwater Management Facilities Easement Agreement, and Shared Use Path Easement Agreement, with the Natural Lands Trust, Parcel # 67-00-03736-00-4.

Supervisor DeLello gave some background on the Valley Forge Road improvements project which this easement is part of.

Ms. McKenna clarified that the agreements were ready to be signed and this is the last easement expected for this project

Supervisor Betz made a motion to accept the Deed of Dedication, Temporary Construction Easement, Stormwater Management Facilities Easement Agreement, and Shared Use Path Easement Agreement, with the Natural Lands Trust, Parcel # 67-00-03736-00-4. The motion was seconded by Supervisor Quigley. The motion passed unanimously.

n) Motion to authorize Final Pay app to D.J. Pinciotti Co., Inc. for the Weber Road Culvert Replacement project in the amount of \$72,116.35.

Mr. Evarts provided background on the project, mentioning that PECO construction delays had impacted the cost of this project to the township.

Supervisor Betz checked to make sure the road was complete, and the engineer was happy with the result. Mr. Evarts confirmed that the work was complete and that it was satisfactory.

Supervisor Betz made a motion to approve the Final Pay Application to D.J. Pinciotti Co., Inc. for the Weber Road Culvert Replacement project in the amount of \$72,116.35. Supervisor Quigley seconded the motion. The motion passed unanimously.

OTHER BUSINESS

Supervisor Betz asked about money spent on Community Day in the amount of \$6,179. Mr. Finnigan confirmed that he would look into it.

PUBLIC COMMENT

Bob Andorn commented on the need for an environmental engineer. He also appreciated the restraint of the Board regarding the band shell and asked that they clarify what they want so there is a better idea of where to put it. Mr. Andorn questioned the ordinance language as it was not supplied to the public. He asked for more information on all items that come before the Board.

Mr. Andorn also indicated that he raised an issue about lighted signs in November of 2023. He stated that there were illegally lit signs in the township, and that only some of them have removed the illegal lighting.

Bill McGrane from Worcester stated that the 84th annual Famers Union Horse Show was a success. He thanked the township and other community partners for their support.

ADJOURNMENT

The meeting was adjourned at 9:35 PM.

NORTH PENN WATER AUTHORITY MINUTES OF THE BOARD OF DIRECTORS MEETING May 28, 2024

William K. Dingman, Chair, called the meeting to order at 7:30 pm. The following Board members attended the meeting: Kenneth V. Farrall, Jeffrey H. Simcox, Michael R. Filiatrault (arrived at 7:39 am), Richard C. Mast, Robert J. Rodgers, Amy J. Cummings-Leight, George E. Witmayer and Arthur C. Bustard. David W. Dedman participated via teleconference call for the Executive Session only. Also present were Anthony J. Bellitto, Jr., P.E., Executive Director, Daniel P. Pearce, Director of Information Technology, Daniel C. Preston, P.E., Director of Asset Management and Strategic Initiatives, Ami Tarburton, Director of Finance and Human Resources, Jonathan C. Hartzell, Director of Operations and Field Services, and Paul G. Mullin, Esquire, Hamburg, Rubin, Mullin, Maxwell & Lupin, Solicitor.

The following items, by agenda number, were discussed:

- 1. <u>MINUTES</u> Upon the motion of Mr. Farrall, seconded by Mr. Rodgers, the Board unanimously approved the Minutes of the April 23, 2024 Board of Directors meeting as presented.
- 2. <u>BIDS</u> There was no Bid Activity this month. Following up from last month's Board meeting discussion, Mr. Preston noted that Contract No. 797 Towamencin Service Renewal Project agreement was being executed this evening and a Notice to Proceed issued.
- 3. <u>**PUBLIC COMMENTS</u>** There were no members of the public in attendance at the meeting.</u>

4. FINANCIALS

The Statement of Income and Expense for the period ending April 30, 2024 was 4.1. highlighted by Ms. Tarburton and discussed. Metered Sales are up about \$126,000 (about 2%) over the same period last year. Total Revenues are down 2.5%, about \$210,000 year to year, due to reduced tapping fees collected from the previous year. Operating expenses are in line with the 2024 budget with no significant variances, reporting at 33% of budget with 33% of time elapsed. Debt Service Coverage is 1.10, which is the minimum of 1.10 required by the Trust Indenture. Total net income to debt ratio is 1.50, above the indenture requirement. The Statement of Net Position for the period ending April 30, 2024 was highlighted and discussed. It was noted that Net Position had increased by 2.6% year to year, an increase of approximately \$4.4 million. The Capital Budget Report indicates expenditures are just 8% of the budget but should fall in line with projections with upcoming pending summer projects. Metered Sales are at or above the 3-year average line. Following discussion, upon the motion of Mr. Farrall, seconded by Mr. Witmayer, the Board voted unanimously to accept the report and file it for future audit. Ms. Tarburton noted that the final audited 2023 financial statements were completed and included in this month's Board packet. There was no change from the draft that was circulated previously. Ms. Tarburton also highlighted the Human Resources and Payroll report.

- <u>OPERATIONS, METER/CUSTOMER SERVICE, AND STATISTICS REPORT</u> Mr. Filiatrault arrived at 7:39 am and was present for all subsequent discussions. The Report for the month of April 2024 was presented, highlighted by Mr. Hartzell, and discussed.
- 6. **ENGINEERING AND WATER QUALITY REPORT** The Report for the month of April 2024 was presented, highlighted by Mr. Preston, and discussed.
- 7. **<u>INFORMATION TECHNOLOGY REPORT</u>** The Report for the month of April 2024 was presented, highlighted by Mr. Pearce, and discussed.
- 8. <u>ADMINISTRATION AND PUBLIC RELATIONS REPORT</u> The Report for the month of April 2024 was presented, highlighted by Mr. Bellitto, and discussed.
- 9. <u>FOREST PARK WATER</u> Mr. Rodgers, Chair of the Forest Park Water Operating Committee, reported that the committee had not met. There was nothing further to report beyond that contained in the Board Packet.

10. MAIN EXTENSIONS

10.1. M.E. 1486 – North Penn Logistics Center, Hatfield Township – Upon the motion of Mr. Rodgers, seconded by Mr. Farrall, the Board authorized unanimously the execution of Resolution No. 24-05-28B for the Deed of Dedication of Public Utility Line and the Deed of Dedication itself, respectively.

11. ITEMS FOR DISCUSSION

- 11.1. Resolution No. 24-05-28A PENNVEST Application for Financial Assistance West Rockhill Township – Mr. Preston discussed the resolution included in the Board packet related to the West Rockhill Transmission Main and attached letter indicating that the Authority will comply with all conditions of the PENNVEST loan. The resolution is required for the PENNVEST application and gives Mr. Dingman signatory authority to execute all closing documents related to the loan application. Once executed and transmitted to PENNVEST, the Authority will have complied fully with all requirements of the loan application. Upon the motion of Mr. Witmayer, seconded by Mr. Farrall, the Board ratified unanimously the Resolution and authorized Mr. Dingman to sign the letter.
- 11.2. Wells Status Update Mr. Bellitto gave a brief overview and background into the Authority use of its groundwater supply. At one time over 30 years ago, the Authority operated 75 wells prior to obtaining surface water from Forest Park and currently operates only four wells. With the pending final PFAS rule of 4 parts per trillion for each PFAS compound being imposed by EPA, the remaining four wells, though compliant currently with the new MCL, are very close to exceeding it. In an

abundance of caution, the remaining four wells will be shut down and only used for emergency purposes, such as a high demand period. Going forward, all water will now come exclusively from the Forest Park Water Treatment Plant. Mr. Hartzell indicated that to keep the wells on active status, compliance monitoring will be continued to ensure that the wells are available, if needed. It was acknowledged that that we are continuing to finalize our source of supply study as we look to future capacity needs and this subject will be discussed further at the July Engineering Committee meeting. The Board concurred with this action related to the remaining active wells and Mr. Bellitto indicated that this is how our source of supply will be represented in future communications.

12. COMMITTEE REPORTS

- 12.1. Engineering Committee Mr. Farrall, Chair of the Engineering Committee, reported that the committee had not met.
- 12.2. Executive Committee Mr. Simcox, Chair of the Executive Committee, reported that the committee had not met.
- 12.3. Finance Committee Mr. Mast, Chair of the Finance Committee, reported that the committee met on April 23, 2024. The meeting minutes were presented for Board approval. Upon the motion of Mr. Mast, seconded by Ms. Cummings-Leight, the Board voted unanimously to approve the minutes of the April 23, 2024 Finance Committee meeting.
- 13. <u>CORRESPONDENCE</u> Various items of correspondence and newspaper articles contained in the Board Packet were reviewed. There was nothing noteworthy or new regarding the information included.

A RESOLUTION TO GRANT PRELIMINARY/FINAL SUBDIVISION APPROVAL OF LOT LINE ADJUSTMENT PLANS FOR WHITE TAIL FARM, LLC

WHEREAS, White Tail Farm, LLC (hereinafter referred to as "Applicant") has submitted a Lot Line Adjustment Plan to Worcester Township and has made application for Preliminary/Final Plan Approval of a plan known as Lot Adjustment Plans for White Tail Farm LLC. The Applicant is legal owner of an approximate 51.34 acre tract of land located at 1543 N. Trooper Road, Worcester Township, Montgomery County, Pennsylvania, in the AGR Agricultural Zoning District of the Township, being Tax Parcel No. 67-00-00661-00-1 (Lot #1) as more fully described in the Deed recorded in the Montgomery County Recorder of Deeds Office; and

WHEREAS, Benjamin G. and Marlena Posen (the "Posens") are the legal owners of an approximate 39,939 square foot vacant tract of land located at Township Line Road, Worcester Township, Montgomery County, Pennsylvania, being Tax Parcel No. 67-00-00661-12-7 ("Posen Lot #2"); and an approximate 2.07 acre tract of land located at 2909 Township Line Road, Worcester Township, Montgomery County, Pennsylvania, being Tax Parcel No. 67-00-03561-00-8 ("Posen Lot #3"); both parcels are located in the AGR Agricultural Zoning District; and

WHEREAS, the Applicant, along with the Posens, proposes the lot consolidation of Posen Lot #2 and Posen Lot #3 to form New Lot #2; and a lot line adjustment between Lot #1 and New Lot #2 to allow the existing driveway for White Tail Farm, LLC, which is currently located on the Posen lot, to be located on the White Tail Farm, LLC, parcel; and

WHEREAS, said plan received a recommendation for Preliminary/Final Plan Approval by the Worcester Township Planning Commission at their meeting on May 23, 2024; and

WHEREAS, the Preliminary/Final Plan for the proposed lot line adjustment, prepared by Robert E. Blue Consulting Engineers, P.C., titled, "Lot Adjustment Plans for White Tail Farm LLC" consisting

of 4 sheets, dated February 1, 2024 (Sheets 1 and 2) and November 30, 2023 (Sheets 3 and 4) with latest revisions dated April 18, 2024, is now in a form suitable for Preliminary/Final Plan Approval (the "Plan(s)" or "Preliminary/Final Plan") by the Worcester Township Board of Supervisors, subject to certain conditions.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING,

IT IS HEREBY RESOLVED by the Board of Supervisors of Worcester Township, as follows:

1. <u>Approval of Plan</u>. The Preliminary/Final Plan as described above, is hereby approved, subject to the conditions set forth below.

2. <u>Conditions of Approval</u>. The approval of the Preliminary/Final Plan is subject to strict compliance with the following conditions:

- A. Compliance with all comments and conditions set forth in the CKS Engineers, Inc. letter of April 19, 2024, relative to the Plan.
- B. The Applicant shall provide to the Township for signature that number of Plans required for recording and filing with the various Departments of Montgomery County, plus an additional three (3) Plans to be retained by the Township, and the Applicant shall have all Plans recorded, and the Applicant return the three (3) Plans to the Township within seven (7) days of Plan recording.
- C. The Applicant shall provide a copy of the recorded Plan in an electronic format acceptable to the Township Engineer, within seven (7) days of Plan recording.
- D. The Applicant shall make payment of all outstanding review fees and other charges due to the Township prior to Plan recording.
- E. The Subdivision shall be in strict accordance with the content of the Plans, notes on the Plans, and

the terms and conditions of this Preliminary/Final Plan Approval.

- F. The cost of accomplishing, satisfying and meeting all of the terms and conditions and requirements of the Plans, notes to the Plans, and this Resolution, shall be borne entirely by the Applicant, and shall be at no cost to the Township.
- G. The following deeds in form satisfactory to the Township Solicitor including legal descriptions satisfactory to the Township Engineer shall be recorded contemporaneously with the plan:
 - a deed for the area to be conveyed by Posen to the Applicant;
 - (2) a deed for the new Lot 1 (Whitetail Farm LLC);
 and
 - (3) a deed for the new Lot 2 (Posen).

3. <u>Waivers</u>. The Worcester Township Board of Supervisors hereby grants the following waiver requested with respect to this Plan:

A. Section 130-35.1(A)(1)[a] of the Worcester Township Subdivision and Land Development Ordinance - plan scale.

4. <u>Acceptance</u>. The conditions set forth in paragraph 2 above shall be accepted by the Applicant and the Posens, in writing, within ten (10) days from the date of receipt of this Resolution.

5. <u>Effective Date</u>. This Resolution shall become effective on the date upon which the Conditions are accepted by the Applicant and the Posens in writing.

BE IT FURTHER RESOLVED that the Plans shall be considered to have received Preliminary/Final Approval once staff appointed by the Worcester Township Board of Supervisors determines that any and all conditions attached to said approval have been resolved to the satisfaction of Township staff and appropriate Township officials have signed said Plans and submitted them for recording with the Montgomery County Recorder of Deeds. Applicant shall provide the Township with executed Preliminary/Final Plans, record plans, and other associated documentation, according to Township procedures. Any changes to the approved site plan will require the submission of an amended site plan for land development review by all Township review parties.
